- **2019 SPENDING PLAN PRESENTATION**

- Mark Gleisner (from the Finance/Stewardship Ministry) presented the 2019 Spending Plan. He referenced the attachment "2019 Narrative Budget" and "Saint Andrew Lutheran Church 2019 Spending Plan Report".

- **RESOLUTION 1 – 2019 BUDGETED SPENDING PLAN ADOPTION**

- Ken read Resolution #1 to the congregation:

With intentional effort to be good stewards of the gifts received, the Ministry groups and Parish staff have submitted budget requests to the Finance/Stewardship ministry who then made adjustments and presented a proposed budget of \$793,445 to the congregation council. This budget was unanimously approved by the council at the meeting on December 20, 2018. The congregation council recommends and requests that this budget be adopted as the 2019 Operational Spending Plan Budget by the voting members at this January 27, 2019 Annual Meeting. Additionally, the congregation of Saint Andrew Lutheran Church shall recommit themselves to any additional gifts and offerings in 2019 as may be required to support any non-budgeted needs for the 2019 program year.

- **Motion made by Mike Fochs and seconded to approve Resolution #1 – 2019 Budgeted Spending Plan.** There was no further discussion on the motion. Motion carried.

- **MSP/CALL COMMITTEE UPDATES – PASTORAL TRANSITION**

- Vice President Kerry Fehrman updated the congregation that the church council has approved six members of the congregation to the Call Committee.
- The first meeting with Pastor Amy Engebose from the Synod is February 13, 2019. The Call Committee will update the Church Council as the process unfolds.

- **CONSTITUTION UPDATE INFORMATION**

- Vice President Kerry Fehrman presented the changes to our congregational constitution to bring it into conformity with the ELCA Model Constitution of 2016 and proposed updates to be made to bylaws. Copies are available on our website or by request through the church office.
Voting to approve the changes is tentatively planned at the time we call a special congregational meeting to call a lead pastor in 2019.

- **RESOLUTION #2 - THANKSGIVING**

- Vice President Kerry Fehrman read Resolution #2:

The Congregation of Saint Andrew Lutheran Church wishes to recognize and give thanks for the faithful, dedicated and caring service provided to its members and the community by our pastors and staff. Additionally, we are grateful for the leadership and support from the elected and appointed members as well as the many who have volunteered their time, talent and financial resources to carry out the mission and ministry of Saint Andrew Lutheran Church.

- **Motion made by Linda Vogen and seconded by Sue Paisar to approve Resolution #2 – Thanksgiving.** There was no further discussion on the motion. Motion carried.
